

## **Promotional Terms & Conditions – FrameMaster NightWolf Twin Pack & FrameMaster NightWolf & Angled TrimMaster Pair Instant Giveaway 2026**

### **1. Introduction**

1.1. These Terms and Conditions apply to the Paslode FrameMaster NightWolf Twin Pack & Paslode FrameMaster NightWolf & Angled TrimMaster Pair promotion (“Promotion”) conducted by ITW across Australia.

1.2. Participation in this Promotion constitutes acceptance of these Terms and Conditions.

1.3. This Promotion is an **instant giveaway** and does **not involve any element of chance**.

### **2. Eligibility**

2.1. The Promotion is open to all Australian residents aged 18 years or over.

2.2. Employees of ITW, its related entities, and their immediate family members (including spouses, parents, siblings, and children) are ineligible to participate.

2.3. Employees of participating stores and their immediate family members are also ineligible.

### **3. Participating Stores and Promotional Period**

3.1. The Promotion commences on **1<sup>st</sup> May 2026** and ends on **30<sup>th</sup> June 2026**, inclusive (“Promotional Period”).

3.2. The Promotion is only available at participating Sydney Tools stores within Australia that advertise or display this Promotion during the Promotional Period.

### **4. How to Participate**

4.1. To qualify, participants must purchase **one (1) FrameMaster NightWolf Twin Pack (Product Code SNW0517)** or **one (1) FrameMaster NightWolf & Angled TrimMaster Pair (Product Code SNW0516)** (“Qualifying Product”) in-store at a participating retailer during the Promotional Period, while stocks last.

4.2. Each Qualifying Product purchased entitles the purchaser to receive an **instant prize** as set out below.

4.3. Multiple purchases in a single transaction will qualify for multiple instant prizes.

4.4. Online purchases and purchases made outside the Promotional Period are not eligible.

4.5. Participation is deemed acceptance of these Terms and Conditions.
